The University's Title IX Sexual Harassment Policy extends to educational programs or activities of the University of Kansas and extends to any retaliatory actions by an individual or an induction process.



To fall into Title IX, the action must be so **Severe**, **Pervasive**, **OR Objectively Offensive** that it would impact action must have occurred within Title IX's jurisdiction.


